- 551.076 Considering the deployment, specific occasions for, or implementation of, security personnel devices
- 551.082 Considering discipline of a public school child, or complaint or charge against personnel
- 551.086 Discussion or deliberation regarding economic development negotiations

Texas Education Code Section

- 39.030(a) Discussion or adopt individual assessment instruments or assessment instrument items

Should any final action, final decision or final vote be required in the opinion of the School Board with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision or final vote shall be either:

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.
